

NOTICE OF A RATE HEARING

Alectra Utilities Corporation has applied to change its electricity distribution rates effective January 1, 2025

The requested rate changes are set using an Ontario Energy Board (OEB) -approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, a typical residential customer and a typical general service customer of Alectra Utilities would see the following changes to their monthly bill:

Rate Zone (RZ)	Horizon RZ	Brampton RZ	PowerStream RZ	Enerource RZ	Guelph RZ
Residential (750 kWh)	\$1.02	\$0.92	\$1.03	\$0.92	\$1.11
General Service less than 50kW (2,000 kWh)	(\$1.39)	(\$4.62)	\$0.09	\$1.29	(\$1.15)

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

Alectra Utilities's request for approval also includes:

- A request for recovery of Renewable Generation Connection Rate Protection funding of \$125,149, \$234,307, and \$130,810 for the Brampton, PowerStream, and Enersource Rate Zones, respectively
- Review of the Deemed Return on Equity to determine if the Earning Sharing Mechanism is triggered for the Horizon, Brampton, PowerStream and Enersource Rate Zones
- Assessment of the allocation methodology applied to the capitalized deferral accounts

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic, and written. The applicant has applied for, and the OEB plans to proceed with a written hearing. If you think a different hearing type is needed, you can write to us to explain why.
